ASSIGNMENT OF TRADEMARK

Assignor covenants and agrees that, upon the request of Assignee, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee, furnish such documents, materials, information and/or assistance, and do all other lawful acts necessary to perfect the assignment of the Trademarks to Assignee and otherwise carry out the intent of this Assignment, provided that Assignee reimburses Assignor for its reasonable out-of-pocket expenses therefor.

4. This Assignment shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under the Assignor's direction, and all those in privity therewith.
