Pursuant to Section 253 of the Delaware General Corporation Law (the "DGCL"), Vestiaire Collective USA, Inc. (the "**Corporation**"), a Delaware corporation, does hereby certify to the following information relating to the merger (the "**Merger**") of the Corporation with and into Tradesy, Inc., a Delaware corporation (the "**Subsidiary**"), with the Subsidiary remaining as the surviving corporation:

1. The Corporation owns all of the outstanding shares of the capital stock of the Subsidiary.
2. The Board of Directors of the Corporation, by resolutions duly adopted by unanimous written consent on December 27, 2022 and attached hereto as Exhibit A, determined to merge the Corporation with and into the Subsidiary and to change the Subsidiary's name to "Vestiaire Collective Americas Inc." pursuant to Section 253 of the DGCL. The sole holder of all of the outstanding shares of the capital stock of the Corporation approved the Merger by written consent on December 27, 2022.
3. The Subsidiary shall be the surviving corporation of the Merger.
4. The Certificate of Incorporation of the Subsidiary, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the surviving corporation, except that Article 1 of such Certificate of Incorporation is hereby amended and restated in its entirety as follows:
  - "1. Name. The name of the Corporation is "Vestiaire Collective Americas Inc."
5. The Certificate of Ownership and Merger and the Merger shall become effective at 5:00 pm US Eastern time on December 31, 2022.
