**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”), is made effective as of June 28, 2023, by PNC BANK, NATIONAL ASSOCIATION (the “**Agent**”), in favor of INTERNATIONAL WIRE GROUP, INC., a Delaware corporation, and OMEGA WIRE, INC., a Delaware corporation (each a “**Grantor**”, and collectively the “**Grantors**”).

WHEREAS, pursuant to that certain (i) Security Agreement dated as of December 23, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among, *inter alia*, Grantors and Agent and (ii) that certain Trademark Security Agreement dated as of December 23, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**TSA**”), by and between, Grantors and Agent, Grantors granted to Agent a security interest in all of Grantors’ right, title and interest in, to and under the Trademark Collateral (as defined in the TSA), including the trademarks described on Schedule A hereto (the trademarks described on Schedule A hereto, collectively, the “**Released Trademarks**”);

WHEREAS, the TSA was recorded in the United States Patent and Trademark Office on December 23, 2021, at Reel 7540 / Frame 0839; and

WHEREAS, Grantors have requested, and Agent wishes to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of Agent’s security interest in the Released Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Agent hereby agrees as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement and TSA, as applicable.


2. Release. Agent, without warranty as to status of title or priority of the encumbrances being hereby released, (i) hereby releases, discharges, terminates and cancels all right, title and interest it has or may have in each of the Released Trademarks, including, without limitation, any security interest it may have in such Released Trademarks, (ii) reassigns and reconveys to the Grantor any and all right, title or interest the Agent may have in the Released Trademarks, and (iii) terminates the TSA.

3. Recordation. Agent or its designee shall file this Release with the United States Patent and Trademark Office, at the sole expense of Grantors, and take further actions necessary to evidence and effectuate the release and termination of the Agent’s security interests and liens on the Released Trademarks.
