RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 23, 2019 by and among RMG ENTERPRISE SOLUTIONS, INC., a Delaware corporation ("RMG Enterprise"), RMG NETWORKS HOLDING CORPORATION, a Delaware corporation ("RMG Networks"), and together with RMG Enterprise, collectively, "Obligors" and each an "Obligor"), and CIBC BANK USA, formerly known as The PrivateBank and Trust Company ("Lender") (as amended, restated, modified or supplemented, the "Trademark Security Agreement"; capitalized terms used herein and not defined herein shall have the ascribed to them in the Trademark Security Agreement), recorded with the United States Patent and Trademark Office – Trademark Division on September 27, 2019 at Reel 6757, Frame 0279, RMG Networks granted to Lender a security interest in all right, title and interest of RMG Networks in and to all trademarks, including those referred to on Schedule 1 attached hereto, all goodwill of the business connected with the use of, and symbolized by, each trademark, and all rights to sue at law or in equity for any infringement or other impairment of the foregoing, including the right to receive all proceeds and damages thereof (collectively, the "Trademark Collateral"); and

WHEREAS, Lender wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender, on behalf of itself, its successors, legal representatives and assigns, hereby (a) relinquishes, releases and discharges its security interest in and to the Trademark Collateral and (b) assigns to RMG Networks any right, title and interest in and to the Trademark Collateral that Lender may have.
