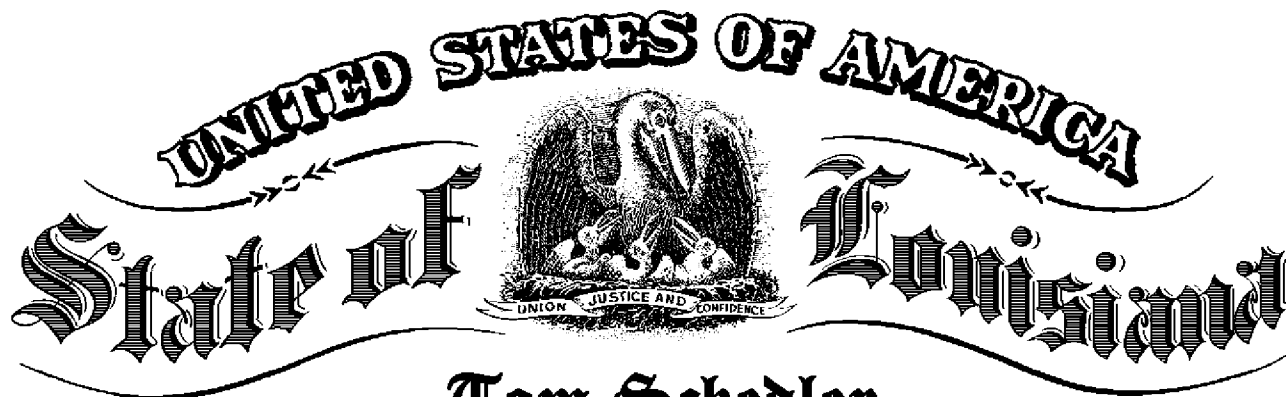

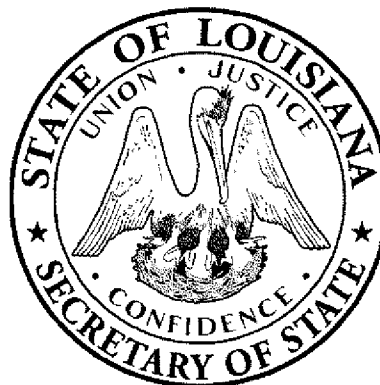

I.

The name of the converting entity is KNIGHT OIL TOOLS, INC., a Louisiana corporation (the "Converting Entity"). The name of the converted entity shall be KNIGHT OIL TOOLS, LLC, a Louisiana limited liability company (the "Converted Entity").

II.

The Converted Entity will be a limited liability company under and subject to the Louisiana Limited Liability Company Law, La. R.S. 12:1301, *et seq.*

III.

The Converting Entity is continuing its existence in the organizational form of the Converted Entity.

IV.

Upon effectiveness of the conversion to be effected by this Conversion Application (the "Conversion"), each outstanding share of Class A Voting Common Stock, no par value per share, of the Converting Entity shall be converted into one Class A Voting Unit of Membership Interest in the Converted Entity and each outstanding share of Class B Non-Voting Common Stock, no par value per share, of the Converting Entity shall be converted into one Class B Non-Voting Unit of Membership Interest in the Converted Entity.

V.

The Conversion has been authorized and approved in accordance with La. R.S. 12:1601, *et seq.*

VI.

The Conversion shall be effective when this Conversion Application is accepted for filing and has been recorded by the Secretary of State of the State of Louisiana.

VII.

Upon the effectiveness of the Conversion, the Articles of Organization of the Converted Entity shall read in their entirety as follows:

ARTICLE I

Name

The name of this limited liability company (hereinafter, the "LLC") shall be:

Knight Oil Tools, LLC

ARTICLE II

Purpose

The purpose of the LLC shall be to engage in any lawful activity for which limited liability companies may be formed under the Act.

ARTICLE III

Management

The LLC shall be managed by managers consisting of a board of directors elected annually by the members as provided in this Article III and the operating agreement of the LLC and (subject to the direction of the board of directors) officers elected as provided in this Article III and the operating agreement of the LLC.

The board of directors shall be composed of not less than one nor more than five natural persons. The classification, qualification, terms of office, manner of election, times and places of meetings and the powers and duties of the directors shall be as from time to time fixed by the operating agreement of the LLC.

Any action which may be taken at a meeting of the board of directors may be taken by a consent in writing signed by all of the directors and filed with the records of proceedings of the board.

Any director absent from a meeting of the board of directors or any committee thereof may be represented by any other director or member, who may cast the vote of the absent director according to the written instruction, general or special, of the absent director.

ARTICLE IV

Term

The LLC shall dissolve on December 31, 2099, unless sooner dissolved as provided in the operating agreement of the Company.

ARTICLE V
Membership Interests

The LLC shall have the authority to issue 1,800,000 shares ("Shares") of membership interests (as defined in the Act), 900,000 of which shall be Class "A" Voting Shares and 900,000 of which shall be Class "B" Non-Voting Shares. The rights represented by the Shares shall be identical in all respects, except that voting rights shall vest exclusively in the holders of Class "A" Voting Shares, who shall be entitled to one vote, either in person or by written proxy, for each share of Class "A" Voting Shares registered in his or her name on the books of the LLC.

Except as otherwise provided in the operating agreement of the LLC, the Shares shall be freely transferable and no consent of the members or board of directors shall be required to effect a transfer of a Share.

ARTICLE VI
Dissolution

Upon dissolution of the LLC, its affairs shall be liquidated by the board of directors, who are hereby vested with full power to sell any and all of the assets and property both real and personal of the LLC and to convey full and complete title thereto, and shall have full power to do and perform all acts necessary, useful and proper to fully and completely liquidate its affairs and distribute the proceeds, if any, among the members in proportion to the amount of Shares held by each.

ARTICLE VII
Amendment

The approval of at least two-thirds of the outstanding Shares present in person or by proxy at a meeting held for such purpose shall be required to amend these Articles of Organization.

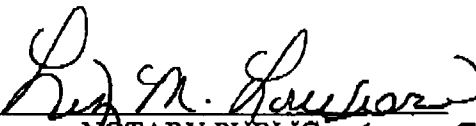
