

TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Agreement") dated as of June 28, 2023, from BRIGHTWOOD LOAN SERVICES, LLC as Collateral Agent for the Secured Parties (the "Collateral Agent"), in favor of AQREVA, LLC, FERN EXPOSITION SERVICES, LLC, UNITED NATIONAL MAINTENANCE, INC., UNITED TEMPS, INC., and TRADE SHOW EXECUTIVE, INC. (individually, each a "Grantor" and collectively, the "Grantors").

WITNESSETH:

WHEREAS, in connection with that certain Intellectual Property Security Agreement, dated June 30, 2022, by and between Collateral Agent and the Grantors (as amended, supplemented or otherwise modified prior to the date hereof, the "Intellectual Property Security Agreement"), each Grantor granted to the Collateral Agent, a security interest in all of its right, title and interest in, and to certain Collateral, including certain of their Trademarks and Patents (as defined in the Intellectual Property Security Agreement) (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Intellectual Property Security Agreement);

WHEREAS, Collateral Agent now wishes to release its liens on, and security interests in, the Collateral as set forth on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Collateral Agent hereby states as follows:

- 1. Release of Security Interest. Collateral Agent hereby terminates the Intellectual Property Security Agreement and terminates, releases and discharges, and sets over and assigns to the Grantors, all of its security interest in the Collateral, including any associated good-will of the business symbolized by the Collateral, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, and reassigns any and all right, title and interest that it may have in or to the Collateral to the Grantors.
- 2. <u>Recordation</u>. Each Grantor or its authorized agent is authorized to record this Agreement with the USPTO.
- 3. <u>Governing Law.</u> This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of New York.
- 4. <u>Further Assurances</u>. Collateral Agent shall take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by such Grantor, and at such Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
