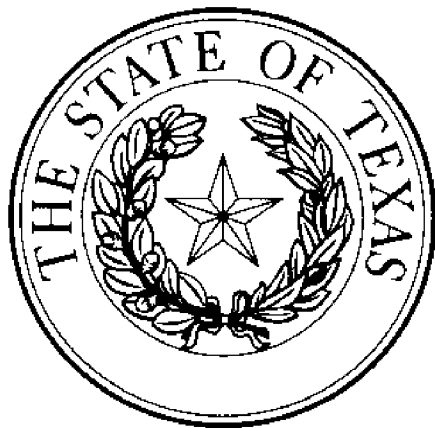

In accordance with the provisions of the Texas Business Organizations Code, as amended (the "TBOC"), Read-a-thon Fundraising Company, Inc., a Texas corporation (the "Converting Entity"), hereby adopts and authorizes for filing with the Secretary of State of Texas, the following Certificate of Conversion:

ARTICLE ONE

The Converting Entity, formerly known as Gottlieb Real Estate Company, was formed in the state of Texas as a corporation under Secretary of State file number 0128567800 on September 23, 1993. The name of the Texas corporation is "Read-a-thon Fundraising Company, Inc."

ARTICLE TWO

The Converting Entity is converting to a limited liability company to be formed under the laws of the state of Texas. The name of the converted Texas entity is "Read-a-thon Fundraising Company, LLC" (the "Converted Entity").

ARTICLE THREE

An executed plan of conversion (the "Plan of Conversion") is on file at the principal place of business of the Converting Entity at 2420 North Highway 287, #112, Mansfield, Texas 76063, and, from and after conversion, the executed Plan of Conversion will be on file at the principal place of business of the Converted Entity at 2420 North Highway 287, #112, Mansfield, Texas 76063.

A copy of the Plan of Conversion will be furnished on written request without cost by the Converting Entity before the conversion or by the Converted Entity after the conversion to any shareholder or member of the Converting Entity or the Converted Entity.

ARTICLE FOUR

The Plan of Conversion sets forth that the name of the Converting Entity is Read-a-thon Fundraising Company, Inc. and that the Converting Entity is being converted from a Texas corporation to a limited liability company to be formed in the State of Texas under the TBOC

and to be known as "Read-a-thon Fundraising Company, LLC" with the Certificate of Formation for such entity attached hereto as Exhibit A.

ARTICLE FIVE

The Plan of Conversion has been adopted and approved as required by the laws under which the Converting Entity was organized and by its governing documents.

ARTICLE SIX

The Converted Entity will be responsible for the payment of all fees and franchise taxes of the Converting Entity and will be obligated to pay such fees and franchise taxes if the same are not timely paid.

ARTICLE SEVEN

The conversion is to be effective when this Certificate of Conversion is accepted and filed by the Texas Secretary of State.

The undersigned, acting as organizer of a limited liability company under the Texas Business Organizations Code, as amended (the "TBOC"), hereby adopts the following Certificate of Formation for the limited liability company:

ARTICLE I: ENTITY NAME, TYPE & INITIAL MAILING ADDRESS

The name of the filing entity being formed hereby is Read-a-thon Fundraising Company, LLC (the "Company"). The type of filing entity being formed is a limited liability company. The initial mailing address for the Company is 2420 North Highway 287, #112, Mansfield, Texas 76063.
