## NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment (this "Agreement"), dated as of June 12, 2013, is entered into *nunc pro tunc* to be effective as of January 1, 2013 (the "Effective Date") by and between Siever's Haarkosmetik GmbH (hereinafter referred to as "Assignor") and Siever's GmbH (hereinafter referred to as "Assignee") with reference to the following facts and circumstances.

WHEREAS, Assignor was the owner of the trademarks and trademark registrations shown in the attached Exhibit A for the designated goods and services and any other goods and services in connection with which Assignor used these marks ("the Marks");

WHEREAS, Assignor previously assigned or intended to assign the Marks to Assignee;

WHEREAS, Assignor desires to document and confirm the prior assignment of the Marks to Assignee; and

WHEREAS, Assignor and Assignee are executing this Agreement so as to correct, *nunc pro tunc*, the chain of title in the Marks to reflect the transfer of ownership from Assignor to Assignee;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor does hereby assign and transfer *nunc pro tunc*, effective as of the Effective Date, to the Assignee the entire right, title, and interest in and to the Marks, the registrations for said Marks and all of its right, title, and interest to said Marks not presently registered, together with the goodwill of the business symbolized by the Marks and the registration thereof, and all other rights which Assignor has enjoyed thereunder both in the United States and throughout all countries of the world, including any and all rights of recovery based on past infringement of said Marks and/or registrations, the same to be held and enjoyed by the Assignee, its successors, and assigns forever and to the full end of the terms for which any of the aforesaid Marks are registered and any renewals of the terms thereof.
