RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the “Release”) is dated as of June 30, 2023 and made by SIXTH STREET SPECIALTY LENDING, INC. (f/k/a TPG Specialty Lending, Inc.), as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the “Collateral Agent”) in favor of G TREASURY SS, LLC, a Delaware limited liability company (f/k/a G Treasury SS, LLC, an Illinois limited liability company) (the “Grantor”).

W I T N E S S E T H

WHEREAS, Grantor and the Collateral Agent entered into that certain Pledge and Security Agreement, dated as of April 9, 2018 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), by and among Grantor, certain other grantors from time to time party thereto and the Collateral Agent;

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Collateral Agent that certain Grant of a Security Interest --Trademarks, dated as of April 9, 2018 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office on April 9, 2018 at Reel/Frame No. 6414/0096, pursuant to which Grantor granted to the Collateral Agent for the benefit of the Secured Parties (as such term is defined in the Security Agreement), a continuing security interest in all right, title and interest of the Grantor in, to and under the Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all of its right, title and interest in and to all of the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to all of the Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that Collateral Agent may have obtained in, to and under the Collateral under the Security Agreement and the Trademark Security Agreement.


