RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of June 30, 2023, by **CIBC BANK USA**, with principal offices at 120 S. LaSalle Street, Chicago, Illinois 60603, in its capacity as administrative agent for the benefit of the financial institutions (the “Lenders”) that are parties to the Credit Agreement referenced in the Security Agreement referenced below (in such capacity, “Administrative Agent”), to **CSAT SOLUTIONS HOLDING CORP**, a Delaware corporation, and **CSAT SOLUTIONS LP**, a Delaware limited partnership (together, “Grantors”).

WITNESSETH

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 20, 2019 (as amended to date, the “Security Agreement”), made by Grantors in favor of Administrative Agent, a security interest was granted by Grantors to Administrative Agent in the Trademark Collateral as such term is defined in the Security Agreement, including without limitation those items listed on Schedule A hereto;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on September 20, 2019, at Reel 6750, Frame 0422; and

WHEREAS, Grantors desire Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantors the continuing security interest in, and any other interest Lenders may have in, Grantors’ right, title, and interest in, to, and under the Trademark Collateral.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks, and any other applicable government officer, record this Release.


This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.


