RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS** (the “*Release Agreement*”), is dated as of June 30, 2023, by BANK OF AMERICA, N.A., a national banking association, in its capacity as agent (the “*Administrative Agent*”).

WHEREAS, U.S. Xpress Enterprises, Inc., a Nevada corporation (“*Obligor*”), executed and delivered that certain Notice of Grant of Security Interest In Trademarks, dated as of June 18, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Trademark Security Agreement*”), granting the Administrative Agent a security interest in and lien on certain trademarks and trademark applications (collectively, the “*Collateral*”) described therein, which includes the Collateral listed on Schedule A hereto, which was recorded with the United States Patent and Trademark Office (“*Office*”) on June 18, 2018, at Reel 006355, Frame 0955;

WHEREAS, the Obligor has requested that the Administrative Agent release, discharge and terminate all liens and security interests granted to the Administrative Agent under the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (a) releases the Obligor from the Trademark Security Agreement, (b) releases, terminates and discharges all liens and security interests and all right, title and interest in, to and under the Collateral, and (c) authorizes and requests that this Release Agreement be recorded at the Office.
