**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of January 3, 2023 by **SILICON VALLEY BANK**, as Administrative Agent (the “**Administrative Agent**”), in favor of **CLICKDIMENSIONS, LLC**, a Georgia limited liability company (the “**Grantor**”).

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of May 9, 2016 (the “**Agreement**”), granting to the Administrative Agent a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on May 10, 2016 at Reel 5791, Frame 0666.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantor has requested that the Administrative Agent provide a document suitable for recording with the USPTO and in any other governmental office to evidence the release of the Administrative Agent’s security interests in and liens on the Trademarks as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder or under the Guarantee and Collateral Agreement (as defined in the Agreement) in Grantor’s right, title and interest in, to and under the Trademarks, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO and in any other governmental office where the Agreement was recorded or the Administrative Agent recorded a lien or security interest against the Trademarks pursuant to the Agreement or the Guarantee and Collateral Agreement.
