RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is dated June 30, 2023, by BMO Harris Bank N.A., a national banking association, acting as administrative agent for the Secured Parties (in such capacity, the "*Administrative Agent*"). Capitalized terms used herein but not defined shall have the same meanings herein as defined in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Administrative Agent and TGS Holdings, LLC, a Tennessee limited liability company ("*Borrower*") and COMPASS ENTERPRISES, LLC, a Virginia limited liability company ("*Compass*"; Compass, together with the Borrower, the "*Grantors*" and each a "*Grantor*") are parties to that certain Trademark Security Agreement, dated as of August 19, 2022 (the "*Trademark Security Agreement*"), which was recorded in the United States Patent and Trademark Office on August 19, 2022 at Reel 7826 and Frame 0876, pursuant to which the Grantors granted a security interest in and collateral assignment of all right, title and interest in and to, the trademarks and service marks set forth opposite their respective names on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (collectively, the "*Trademarks*"); and

WHEREAS, the Grantors have requested that the Administrative Agent release its security interests in the Trademarks and reassign the same to the Grantors;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



- (i) the Trademarks;
- (ii) the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and
- (iii) all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof.
