TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release of Trademark Security Agreement is effective as of December 31, 2021 ("Termination and Release"), by PEAPACK-GLADSTONE BANK ("Lender").

WHEREAS, that certain Trademark Security Agreement, dated as of February 25, 2021, (as heretofore amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement"), was executed in favor of Lender by REICH & TANG DEPOSIT NETWORKS, LLC, REICH & TANG DEPOSIT SOLUTIONS, LLC, and STABLE CUSTODY GROUP II LLC (each a "Loan Party" and together the "Loan Parties"), pursuant to which the Loan Parties granted to the Lender, to secure the payment of certain obligations to the Lender, a security interest in the Loan Parties' right, title and interest in, to and under certain assets, including the trademarks set forth on Schedule 1 (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on February 26, 2021, at Reel 7204, Frame 0656; and

WHEREAS, Lender agrees to execute this Termination and Release in order to evidence the termination and release of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

2. Release of Security Interest. Intending to be legally bound hereby, the Lender hereby releases, discharges and terminates any and all liens, security interests, rights, title and interests of the Lender under the Trademark Security Agreement, including in and to the Trademark Collateral and the goodwill symbolized thereby, and hereby transfers and assigns to the Loan Parties any and all right, title, and interest that the Lender may have obtained in and to the Trademark Collateral and waives and relinquishes all its rights, powers, privileges, and remedies with respect to the Loan Parties and their respective successors and assigns for all covenants, obligations, liabilities, and warranties, in association with the Trademark Collateral.

3. Lender hereby authorizes the Loan Parties or a Loan Party's authorized representatives to record this Termination and Release with the United States Patent and Trademark Office.

IN WITNESS WHEREOF, the Lender duly executes this Termination and Release of Trademark Security Agreement.
