Assignor shall communicate to Assignee any facts known to them respecting said trademarks, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid Assignee, its successors, and assigns, to obtain and enforce proper protection for said trademarks in the United States, and in any and all foreign countries.
