## SHORT-FORM TRADEMARKS SECURITY AGREEMENT

WHEREAS, each entity set forth on the signature pages hereto (each, a “Grantor”) has used, intends to use, or is using and is the owner of the trademarks and the trademark registrations and registration applications for same listed in the attached Schedule of Trademarks (as defined in the Security Agreement) set forth across such Grantor’s name;

WHEREAS, each Grantor has contemporaneously with the execution of this Short-Form Trademarks Security Agreement entered into the Pledge and Security Agreement dated as of June 9, 2023 (as modified from time to time, the “Security Agreement”), in which such Grantor has granted a security interest with respect to the Trademark Collateral (as defined therein) in favor of SIS Holdings, L.P., as Lender (“Lender”); and


WHEREAS, pursuant to the Security Agreement, each Grantor has agreed with Lender to execute this Short-Form Trademarks Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby grants to Lender, to the extent provided in the Security Agreement (the terms and conditions of which are hereby incorporated herein), a security interest in all of its right, title and interest in, to and under all the trademarks, whether now owned or at any time hereafter acquired, of such Grantor that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office, including the trademarks listed on the attached Schedule of Trademarks, and all registrations and pending applications for same (excluding any intent-to-use United States trademark application for which an “Amendment to Allege Use” or “Statement of Use” has not been filed under 15 U.S.C. § 1051(c) or (d), respectively, or, if filed, has not been deemed in conformance with 15 U.S.C. § 1051 (a) or (c) and accepted by the USPTO, unless and until a “Statement of Use” or “Amendment to Allege Use” is filed, has been deemed in conformance with 15 U.S.C. § 1051 (a) and (c) or examined and accepted, respectively, by the USPTO, as collateral security for the prompt and complete payment and performance when due of all the Secured Obligations (as defined in the Security Agreement). Notwithstanding the foregoing, in the event of any conflict between this Short Form Trademarks Security Agreement and the Security Agreement, the Security Agreement shall control.


