RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 6th day of July, 2023, by EAST WEST BANK, as administrative agent (“Agent”), in favor of SOURCEABILITY NORTH AMERICA LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, the Grantor entered into a certain trademark security agreement dated December 23, 2022 (the “Trademark Security Agreement”) with Agent, notice of which was recorded on December 27, 2022 at the United States Patent and Trademark Office at Reel 7930, Frame 0956.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Agent, in and to all of its Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent, on behalf of itself and the Lenders hereby, hereby absolutely and unconditionally terminates, releases, reconveys and forever discharges all liens and security interests in favor of Agent in the Trademark Collateral, including the Trademarks listed on Schedule A attached hereto.

Agent authorizes and requests that the United States Patent and Trademark Office and any applicable governmental officer records this Release.

Agent agrees, at the Grantor's sole cost and expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed in accordance with the law of the State of New York.

Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement.
