**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 7, 2023 (“Release”), is made by Acquiom Agency Services LLC, a Colorado limited liability company, as Administrative Agent (“Administrative Agent”) in favor of Circle Graphics, Inc., a Delaware corporation (“Grantor”).

**WHEREAS**, pursuant to that certain Loan and Security Agreement dated as of September 30, 2019 (as amended, modified, supplemented, increased, extended, restated, refinanced and/or replaced from time to time, the “Loan Agreement”) by and among the Grantor, Administrative Agent, and others party thereto, and the Trademark Security Agreement dated as of June 21, 2021 by and among the Grantor and Administrative Agent (“Trademark Security Agreement”), Grantor granted, pledged and collaterally assigned a security interest in, and a Lien on, the Trademark Collateral to the Administrative Agent, for the benefit of the Lending Parties; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on June 22, 2021 at Reel 7332 Frame 0458.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lending Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Loan Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Lending Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest and Lien to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Loan Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Lending Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
