**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of July 3, 2023, by APOGEM CAPITAL LLC (as successor by appointment to Madison Capital Funding LLC) (“Secured Party”) to SOCIUS INSURANCE SERVICES, INC., a California corporation (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, pursuant to that certain Notice of Grant of a Security Interest – Trademarks dated as of June 30, 2021 (the “Security Agreement”), Grantor granted a security interest to Secured Party in certain Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 30, 2021, at Reel 7393, Frame 0442; and

WHEREAS the Assignment of Intellectual Property Security Agreement granted to Apogem Capital LLC was recorded by the Trademark Division of the United States Patent and Trademark Office on May 4, 2022 at Reel 7712, Frame 0406.

WHEREAS, Grantor has requested that Secured Party release its security interest in the Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor’s right, title and interest in and to all right, title and interest of the Grantor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by Trademarks owned by the Grantor, including those set forth on Schedule 1 hereto (collectively the “Collateral”).

2. Secured Party hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party’s right, title and interest in and to the Trademarks and the Trademark Collateral.

3. Secured Party hereby terminates and cancels the Security Agreement.
