## ATTESTATION OF MERGER AND CHANGE OF NAME

The undersigned, Maître Thibault GALLOT LAVALLEE , Notary in Neuilly sur Seine (Hauts de Seine)

In view of the documents provided to us

Certify and attest that :

- (i) that in terms of decisions dated 30 December 2011:
  - a. the company CLARINS, a French company whose registered office was 4 rue Berteaux Dumas, 92200 Neuilly sur Seine, registered at the Nanterre Trade and Companies Registry (RCS) under the No. 775 668 155 was absorbed by the company SOCIETE FINANCIERE FC, Public Limited Company with a Board of Directors and a Supervisory Board whose registered office was located at 4 rue Berteaux Dumas, 92200, Neuilly sur Seine, France, registered at the Nanterre Trade and Companies Registry under the No. 330 589 755;
  - b. the company SOCIETE FINANCIERE FC modified its corporate name to become CLARINS (RCS 330 589 755);
- (ii) that in terms of this absorption operation, CLARINS (RCS 330 589 755), absorbing company, became the owner of all the trademarks and industrial property rights of the absorbed company CLARINS (RCS 775 668 155) on the date of the definitive completion of the merger.
- (iii) that CLARINS (RCS 330 589 755) has enjoyed these rights retroactively since 30/12/2011.
- (iv) that the decision dated 29 April 2014 with effect on 17 June 2014, the company CLARINS (RCS 330 589 775) modified the address of its registered office, which has been since at 9 rue du Commandant Pilot - 92200 Neuilly sur Seine, France;
- (v) that by decision dated 21 December 2018, the company CLARINS (RCS 330 589 775) modified its legal form to become a Simplified Joint-stock Company (Société par actions simplifiée) (SAS).
