TRADEMARK ASSIGNMENT

Assignor does hereby assign and transfer to Assignee any and all of Assignor's right, title, and interest in and to the Mark and any and all associated goodwill thereto, all trade dress, all common law rights, and any applications, registrations, and any renewals and extensions thereto, and in and to all income, royalties, damages, claims and payments now or hereafter due or payable with respect thereto, and to all causes of action, either in law or in equity, for past, present or future infringement based on the Mark, and to all rights corresponding to the foregoing throughout the world, including but not limited to any and all associated goodwill in and to the Marks.


Assignor warrants and represents that it has full authority and power to make this assignment, can quitclaim any and all rights it may have in the Mark, and can make assignment of the same to Assignee free and clear of any encumbrance, lien, or other interest with respect to any third parties, and has the right to transfer clear title to the Mark to Assignee. Assignor shall cooperate to execute and deliver any further documents reasonably requested by Assignee for the purpose of effectuating the assignment contemplated herein, including without limitation: (1) in the preparation and prosecution of any application for renewal of a registration covering the Mark, (2) in the prosecution or defense of any interference, opposition, infringement, or other proceedings that may arise in connection with the Mark, (3) in obtaining any additional protection for the Mark that Assignee reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in the United States or for all foreign countries, and (4) in the recordation or perfection of this Assignment.


