TERMINATION OF IP COLLATERAL AGREEMENT

THIS TERMINATION OF IP COLLATERAL AGREEMENT (this “*Termination*”) is made as of June 27, 2023 with reference to that certain Intellectual Property Collateral Agreement, dated as of July 2, 2015 (the “*IP Collateral Agreement*”), by and among TRANSFORCE, INC. (the “*Grantor*”), in favor of TFI SUBDEBT, LLC (in such capacity, the “*Collateral Agent*”).

WHEREAS, pursuant to the IP Collateral Agreement, Grantor granted to Collateral Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the IP Collateral Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Collateral Agent agrees as follows:

1. Release.

(a) Collateral Agent hereby (i) releases, discharges, terminates and cancels all of its security interest and all other liens that it has in, to and under the Trademark Collateral and (ii) reassigns, grants and conveys to Grantor all of Collateral Agent’s right, title and interest in and to the Trademark Collateral, including the trademarks and trademark applications set forth on Schedule I attached hereto and all proceeds of the foregoing;

(b) Collateral Agent hereby terminates and cancels the IP Collateral Agreement; and

(c) Collateral Agent agrees to take all further actions, and provide to Grantor and its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of all documents or other instruments), reasonably requested by Grantor, at Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.

2. Authorization to Record. Collateral Agent authorizes and requests that Grantor file and record this Termination with the United States Patent and Trademark Office.

3. Governing Law. This Termination and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted with, the laws of the State of Delaware.




