RELEASE OF SECURITY INTEREST

This Release of Security Interest (“Release”) is made as of July 13, 2023 (the “Release Date”), by **PACIFIC WESTERN BANK**, a California state-chartered bank (“Bank”), for the benefit of **RISKLENS, INC.**, a Delaware corporation (as converted from RiskLens, Inc., a Washington corporation) (“Grantor”), with its principal place of business located at 601 W Main Avenue, Suite 910, Spokane, Washington 99201.

Recitals

WHEREAS Grantor has entered into that certain Loan and Security Agreement, dated as of July 5, 2018 with Bank (as amended or supplemented from time to time, the “Loan Agreement”);

WHEREAS pursuant to the terms of the Loan Agreement, Grantor granted to Bank a security interest in all of Grantor’s right, title and interest in, to and under its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C of the Security Agreement (as defined below)), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof (collectively, “Intellectual Property Collateral”) under that certain Amended and Restated Intellectual Property Security Agreement dated as of April 12, 2021 (as amended or supplemented from time to time, the “Security Agreement”);

WHEREAS Bank has filed with the United States Patent and Trademark Office (the “USPTO”) notices of security interests in the Patents and Trademarks described on Exhibits A and B attached hereto (respectively); and

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to release its security interest in the Intellectual Property Collateral.

Agreement

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank agrees that:

1. As of the Release Date, it hereby irrevocably and forever terminates, releases and discharges any and all security interest in the Intellectual Property Collateral.
2. It understands and agrees that this Release may be recorded by or for Grantor with the USPTO.
3. It will execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that Grantor may reasonably request to effect the intent and purpose of this Release.
