 - (i) the Assigned Marks listed in the attached **Exhibit A**, and any registrations and renewals thereof;
 - (ii) the goodwill of that portion of Assignor's ongoing and existing business connected with, pertaining to, and symbolized by the Assigned Marks; and
 - (iii) the ownership of all causes of action for, and claims for damages by reason of, infringement of the Assigned Marks, which actions arose prior to the date of execution hereof.
2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.
3. Assignor hereby agrees that Assignee shall have the right to record this instrument of assignment.


