## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (the “Agreement”) is made and entered into this 16<sup>th</sup> day of March, 2023 by and between **Amaia, LLC**, a New Jersey limited liability company (“Amaia” or “Assignor”) with an address at 5 Penn Plaza, 23<sup>rd</sup> Floor, #2378, New York, New York 10001, and **Trouvaille Watches, LLC**, a New York limited liability company (“Trouvaille” or “Assignee”) with an address at 347 West 39th Street, c/o of Currimbhoy & Co, Suite 7W, New York, NY 10018.

WHEREAS, Assignor and Trouvaille have determined that it is in the best interests of Assignor to assign to Trouvaille all of Assignor’s right, title and interest in and to any and all trademarks and service marks owned by Assignor, whether registered or not, including, without limitation, the trademarks listed on the attached **Exhibit A**, together with all filings, registrations and documents associated therewith, and the goodwill and business associated therewith, throughout the world (collectively, the “Assets”); and

WHEREAS, the Assignor desires to assign to Trouvaille, and Trouvaille desires to assume, all right, title and interest in and to the Assets;

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the parties hereto, intending to be bound hereby, agree as follows:

1. Effective on the date set forth above, the Assignor hereby sells, assigns, transfers and sets over to Trouvaille, its successors, legal representatives and assigns, all of Assignor's right, title and interest in and to the Assets, including any rights under common law, and including, without limitation, all claims, proceeds and causes of action relating thereto and the right to sue for past, present and future infringements of said Assets, the same to be held and enjoyed by Assignee for its own use and on behalf of its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this assignment not been made.

2. The Assignor hereby requests the United States Patent and Trademark Office (“USPTO”), or the relevant foreign trademark office, to record Trouvaille, as assignee and owner of the Assets and to issue to Assignee any and all registrations resulting from said applications, or any renewals of said registrations.

3. The Assignor agrees to execute and deliver at a future date, for no additional consideration, any additional documents that Trouvaille reasonably determines are required to reflect the Trouvaille’s ownership of the Assets anywhere in the world.

4. The Assignor will assist in obtaining or providing any further documents which may be required to confirm chain of title thereto.

5. This Agreement may be signed in counterparts, each of which shall be deemed an original, but together shall constitute a single instrument

6. This Agreement shall be governed by and construed under the laws of the State of New York.

7. EACH OF THE PARTIES HERETO HEREBY WAIVE ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING RELATING TO THIS AGREEMENT, THE OBLIGATIONS HEREUNDER AND EACH PARTY REPRESENTS TO THE OTHER THAT THIS WAIVER IS KNOWINGLY, WILLINGLY AND VOLUNTARILY GIVEN.

8. THIS AGREEMENT IS THE FINAL EXPRESSION OF THE AGREEMENT AND UNDERSTANDING OF THE PARTIES AND MAY NOT BE CONTRADICTED BY EVIDENCE OF ANY ALLEGED ORAL AGREEMENT.

9. This Agreement may be executed by facsimile signatures and delivered electronically in pdf format, each of which shall be given the same legal weight as though they were original signatures.
