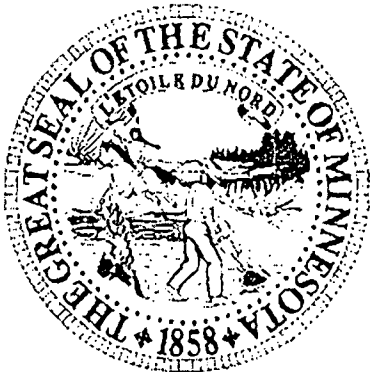

**ARTICLES OF MERGER
OF
EDL MASSMAN, LLC, a Minnesota limited liability company,
IDEAL-PAK MASSMAN, LLC, a Minnesota limited liability company,
AND
DTM MASSMAN, LLC, a Minnesota limited liability company
INTO
MASSMAN COMPANIES, INC., a Delaware corporation**

Pursuant to Chapter 322C of the Minnesota Statutes, EDL Massman, LLC, a Minnesota limited liability company, Ideal-Pak Massman, LLC, a Minnesota limited liability company and DTM Massman, LLC, a Minnesota limited liability company (collectively, the “**Merging Organizations**”), and Massman Companies, Inc., a Delaware corporation (the “**Surviving Organization**”), hereby adopt the following Articles of Merger:

1. **Constituent Organizations.** The constituent organizations are (i) EDL Massman, LLC, a Minnesota limited liability company (ii) Ideal-Pak Massman, LLC, a Minnesota limited liability company and (iii) DTM Massman, LLC, a Minnesota limited liability company, each governed by Chapter 322C of the Minnesota Statutes, known as the Minnesota Revised Uniform Limited Liability Company Act (the “**Act**”), and Massman Companies, Inc., a Delaware corporation governed by Title 8, Chapter 1 of the Delaware Code, known as the Delaware General Corporation Law (the “**DGCL**”).
2. **Surviving Organization.** The Surviving Organization is Massman Companies, Inc., a Delaware corporation governed by the DGCL.
3. **Effective Time.** The merger of the Merging Organization with and into the Surviving Organization shall become effective at 11:59 pm. Central daylight time on June 30, 2023 (the “**Effective Time**”).
4. **Organizational Documents.** The Certificate of Incorporation of the Surviving Organization in effect at the Effective Time shall be the Certificate of Incorporation from and after the Effective Time.
5. **Approval.** An Agreement and Plan of Merger (the “**Agreement**”) has been duly approved and adopted by the sole member of the Merging Organizations pursuant to Chapter 322C of the Minnesota Statutes and the Board of Directors of the Surviving Organization in accordance with the Act and the DGCL, respectively.
6. **Location and Furnishing of Agreement.** The Agreement is on file at 1010 Lake Street, Villard, MN 56385, the principal place of business of the Surviving Organization. A copy of the Agreement will be furnished by the Surviving Organization on request, without cost, to the sole member of the Merging Organizations and to any stockholder of the Surviving Organization.

7. **Service of Process.** The Surviving Organization hereby appoints, effective at the Effective Time, Jeffrey J. Hohn as its agent to accept service of process in any such proceeding and the address to which process may be forwarded is:


