

INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment ("<u>Agreement</u>") is entered into as of June 30, 2023, by and between Rauckman Utility Products, LLC, a Missouri limited liability company, James B. Rauckman, an individual, and Shirley S. Raukman, an individual (each, an "<u>Assignor</u>" and collectively, the "<u>Assignors</u>") and National Safety Apparel, Inc., an Ohio corporation ("<u>Assignee</u>").

WHEREAS, the Assignors and Assignee are parties to that certain Asset Purchase Agreement of even date herewith (the "*Purchase Agreement*").

WHEREAS, pursuant to the terms of the Purchase Agreement, the Assignors agreed to, among other things, sell, assign, transfer, convey and deliver to Assignee all of Assignors' right, title, and interest in and to the Seller Owned Intellectual Property Assets (the "Purchased IP"), including, but not limited to, (i) all of Assignors' right, title, and interest in and to the domain names set forth in Schedule A attached hereto (the "Domain Names"); (ii) all copyright rights in and to the content uploaded or posted to the websites accessible via the Domain Names; (iii) the registered copyrights set forth in Schedule A attached hereto; (iv) the trademarks set forth in Schedule A attached hereto; (v) the patents set forth in Schedule A attached hereto; and (vi) all goodwill associated with any of the foregoing.

WHEREAS, pursuant to the Purchase Agreement, Assignors desire to assign to Assignee, and Assignee desires to acquire from Assignors, the Purchased IP.

WHEREAS, as a condition to the closing of the transactions contemplated under the Purchase Agreement, all of the Parties have agreed to execute and deliver this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignors, Assignors and Assignee hereby covenant and agree as follows:

- 1. <u>Definitions</u>. All capitalized terms used in this Agreement but not otherwise defined herein are given the meanings set forth in the Purchase Agreement.
- Assignment of Purchased IP. Assignors hereby irrevocably sell, assign, transfer, convey, and deliver to Assignee all right, title and interest in and to the Purchased IP, including with respect to trademarks included in the Purchased IP the good will associated with the business in connection with which said trademarks are used, free and clear of any encumbrance, and all other corresponding rights that are or may be hereafter secured under the laws of any country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made, and all claims for damages by reason of past, present or future infringement or other unauthorized use of the Purchased IP, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

- Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and assistance that Assignee reasonably may deem appropriate to effectuate the purposes of this Assignment, including, but not limited to, effectuating the transfer of the possession and control of the Domain Names to Assignee with the registrar of the Domain Names, and taking any steps and completing any documents or forms that may be required by each registrar, including, as necessary, executing said documents or forms in the presence of an authorized notary public and delivering such documents or forms properly executed to the registrar and distributing copies of the completed and receipted registrar transfer documents to the parties to this Assignment.
- 4. <u>Purchase Agreement Controlling</u>. To the extent that any provision of this Agreement is inconsistent or conflicts with the Purchase Agreement, the provisions of the Purchase Agreement shall control. Nothing contained in this Agreement shall be deemed to supersede, enlarge, or modify any of the obligations, agreements, covenants, or warranties of Assignor or Assignee contained in the Purchase Agreement.
- 5. <u>Counterparts</u>. The parties may execute this Agreement in multiple counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument. A facsimile of any executed counterpart transmitted electronically by e-mail or fax shall be as binding as an original signature.
- 6. <u>Governing Law</u>. This Agreement shall be governed by and construed in accordance with the same law governing the Purchase Agreement without giving effect to any choice of law or conflict of law provision or rule that would cause the application of the laws of any other jurisdiction. Venue for any proceeding, judicial or otherwise, concerning this Agreement shall be the same venue as required or permitted under the Purchase Agreement.
- 7. <u>General</u>. If any provision of this Assignment is found to be invalid by any court having competent jurisdiction, the invalidity of such provision will not affect the validity of the remaining provisions of this Assignment, all of which will remain in full force and effect. No waiver of any terms of this Assignment will be deemed a further or continuing waiver of such term or any other term. Any changes to this Assignment must be made in writing and signed by an authorized representative of both parties.
