## RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (this "Release") dated as of July 11, 2023 (the "Effective Date"), is made by HERCULES CAPITAL, INC., a Maryland corporation, in its capacity as administrative agent and collateral agent (together with its successors and assigns in such capacity, "Agent") for itself and the Lenders (as defined below) in favor of IVERIC BIO, INC., a Delaware corporation, IVERIC BIO GENE THERAPY LLC, a Delaware limited liability company, and ORION OPHTHALMOLOGY LLC, a Delaware limited liability company (each individually and collectively, the "Grantor").

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of July 26, 2022, by and among Agent, certain financial institutions party thereto (the "Lenders") and Grantor (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), Grantor granted to Agent, for its benefit and the benefit of the Lenders, a security interest in and to certain collateral;

WHEREAS, pursuant to the Loan Agreement, Grantor and Agent executed and delivered for recordation with the United States Patent and Trademark Office (the "USPTO") an Intellectual Property Security Agreement, dated as of July 26, 2022 (the "IP Security Agreement");

WHEREAS, the IP Security Agreement was recorded with the USPTO (i) in respect of Patents, on August 5, 2022, at Reel/Frame 061088/0048 and (ii) in respect of Trademarks, on September 16, 2022, at Reel/Frame 7849/0006; and

WHEREAS, Agent has agreed to release, discharge, terminate and cancel its security interest in all Intellectual Property Collateral as provided for in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Loan Agreement or the IP Security Agreement, as applicable.
2. Release. Agent, without representation, warranty or recourse of any kind, hereby releases, discharges, terminates and cancels all of its security interest and liens of any kind, nature or description it or any Lender holds, whenever and however arising, pursuant to the IP Security Agreement (the "Released Collateral"), including (without limitation) in and to the following:
  - a. All Patents set forth in Exhibit A attached hereto;
  - b. All Trademarks set forth in Exhibit B and
  - c. any and all claims for damages by way of past, present and future infringement of any of the foregoing, with the right, but not the obligation, to sue for and

collect such damages for said use or infringement of the intellectual property rights identified above.

If and to the extent that Agent has acquired any right, title or interest in and to the Released Collateral under the IP Security Agreement, Agent, without representation, warranty or recourse of any kind, hereby releases such right, title or interest. This Release is applicable only and solely with respect to the Released Collateral and to no other collateral arising under the Loan Agreement. Unless otherwise separately agreed, Agent retains all security interests, liens, rights, titles and interests pledged and granted to Agent under the Loan Agreement with respect to all such other collateral, and Agent's security interest, liens, rights, titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.


3. Further Assurances. Agent agrees to take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
4. Recordation. Agent authorizes Grantor or its designee to file this Release for recordation with the USPTO, and Grantor authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release.
5. Collateral Agent. In carrying out its responsibilities hereunder, Agent shall have all of the rights, powers, privileges, protections, duties, indemnities, and immunities which Agent possesses in such capacity under the Loan Agreement.
6. Execution in Counterparts. This Release may be executed in any number of counterparts and by different parties on separate counterparts, each of which, when executed and delivered, is an original, and all taken together, constitute one agreement.
7. Governing Law. This Release shall be governed exclusively under the laws of the State of California, without regard to principles of conflicts of law.
