TRADEMARK, COPYRIGHT AND DOMAIN NAME ASSIGNMENT

This **TRADEMARK, COPYRIGHT AND DOMAIN NAME ASSIGNMENT** (the "Assignment") is made and entered into as of the 1st day of June, 2015 by and between **MAINETODAY MEDIA, INC.**, a Delaware corporation ("Assignor"), and **MTM ACQUISITION, INC.**, a Maine corporation ("Assignee").

WHEREAS, Assignor, certain affiliated entities of Assignor, Assignee, and an affiliated entity of Assignee are parties to an Agreement for Purchase and Sale of Business Assets dated as of April 28, 2015 (the "APA") pursuant to which Assignor has agreed to sell to Assignee on the date hereof substantially all of the assets of the Assignor; and

WHEREAS, as provided in the APA, Assignor has agreed to assign and transfer to Assignee all of its right, title and interest in and to Assignor's trademarks, including Assignor's registered trademarks, which are listed on **Exhibit A** attached hereto (such registered and unregistered trademarks, the "Trademarks"); and

WHEREAS, as provided in the APA, Assignor has agreed to assign and transfer to Assignee all of its right, title and interest in and to Assignor's copyrights, including Assignor's registered copyrights, which are listed on **Exhibit B** attached hereto (such registered and unregistered copyrights, the "Copyrights"); and

WHEREAS, as provided in the APA, Assignor has agreed to assign and transfer to Assignee all of its right, title and interest in and to Assignor's domain names, which are listed on **Exhibit C** attached hereto (the "Domain Names").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Capitalized Terms. Capitalized terms used herein without definition shall have the meanings assigned to them in the APA.
2. Assignment of Assignor's Rights to Trademarks. Assignor hereby grants, bargains, sells, conveys, assigns and transfers to Assignee, its successors and assigns, all of Assignor's right, title and interest, legal and equitable in and to the Trademarks, all trademark registrations and applications for registration thereof, the goodwill associated therewith, all common law rights thereto, all rights in licenses and agreements connected therewith, all rights to sue and recover for damages and profits and all other remedies for past or future infringements thereof, and all other properties and rights related thereto.
3. Assignment of Assignor's Rights to Copyrights. Assignor hereby grants, bargains, sells, conveys, assigns and transfers to Assignee, its successors and assigns, all of Assignor's right, title and interest, legal and equitable in and to the Copyrights, together with all derivations, variations and combinations thereof, all copyright registrations and applications for registration thereof, and all common law rights thereto, all rights in licenses and agreements connected therewith, the goodwill awarded therewith, all rights to sue and recover for damages and profits

and all other remedies for past or future infringements thereof, and all other properties and rights related thereto.

4. Assignment of Assignor's Right to Domain Names. Assignor hereby grants, bargains, sells, conveys, assigns and transfers to Assignee, its successors and assigns, all of Assignor's right, title and interest, legal and equitable, in, to and under the Domain Names together with the goodwill associated therewith, and all other properties and rights related thereto.

5. Terms of the APA. To the extent any provision of this Assignment conflicts with any provision of the APA, the APA will govern.

6. Further Assurances. From time to time hereafter, the Assignor and Assignee shall execute and deliver, or shall cause to be executed and delivered, such additional instruments, certificates or documents, and shall take all such actions, as may reasonably be requested by the other party or parties, for the purpose of implementing or effectuating the provisions of this Assignment.

7. Representations and Warranties. This Assignment does not supersede, expand, amend, or limit in any way any of the representations, warranties, or indemnities contained in the APA.

8. Effective Date. Notwithstanding anything to the contrary herein, this Assignment shall be effective as of the date of, and contemporaneously with, the consummation of the transactions contemplated by the APA.

9. Further Assurances. From time to time hereafter, the Assignor and Assignee shall execute and deliver, or shall cause to be executed and delivered, such additional instruments, certificates or documents, and shall take all such actions, as may reasonably be requested by the other party or parties, for the purpose of implementing or effectuating the provisions of this Assignment.

10. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of Maine.

11. Severability. In the event that any provision or term of this Assignment, or any word, phrase, clause, sentence or other portion thereof is held to be unenforceable or invalid for any reason, such provision or portion thereof will be modified or deleted in such a manner as to make this Assignment, as modified, legal and enforceable to the fullest extent permitted under applicable laws.




