This INTELLECTUAL PROPERTY ASSIGNMENT (this “Assignment”) is made and entered into as of June 30, 2023 (the “Effective Date”) by and between PricewaterhouseCoopers LLP, a Delaware limited liability partnership with an address at PricewaterhouseCoopers Center, 300 Madison Avenue, New York, NY 10017 (“Assignor”), and PwC Product Sales LLC, a Delaware limited liability company with an address at PricewaterhouseCoopers Center, 300 Madison Avenue, New York, NY 10017 (“Assignee”). Assignor and Assignee are referred to herein individually as a “Party,” and collectively as the “Parties.”

WHEREAS, Assignor and Assignee have entered into the Intellectual Property Contribution Agreement dated June 30, 2023 (the “IP Contribution Agreement”); and

WHEREAS, in connection with the IP Contribution Agreement, the parties to the IP Contribution Agreement desire that Assignor transfer to Assignee all of the right, title and interest of Assignor in and to the patents and patent applications, trademarks and trademark applications (together with all goodwill associated therewith and symbolized thereby in each case), and copyrights and copyright applications set forth on Attachment A attached hereto (collectively, the “Assigned IP”); and

WHEREAS, Assignee wishes to acquire all of Assignor’s right, title and interest in and to the Assigned IP, and Assignor wishes to assign such right, title and interest in and to such Assigned IP to Assignee.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth below, the Parties hereby agree as follows:

1. Transfer of Assigned IP. Effective as of 11:59:00 PM Eastern Daylight Time on the Effective Date, Assignor does hereby irrevocably contribute, transfer, convey, assign and deliver to Assignee and its successors and assigns, and Assignee does hereby unconditionally accept and assume: (a) all of Assignor’s right, title and interest in and to the Assigned IP (but excluding in all cases all intent-to-use United States trademark applications for which an amendment to allege use or statement of use has not been filed under 15 U.S.C. § 1051(c) or 15 U.S.C. § 1051(d), respectively, or if filed, has not been deemed in conformance with 15 U.S.C. § 1051(a) or examined and accepted, respectively, by the United States Patent and Trademark Office (collectively, the “Intent-To-Use Applications”), provided that upon such filing and acceptance, such Intent-To-Use Applications shall be included in the definition of Assigned IP); (b) all royalties, fees, income, payments, and other proceeds now or hereafter due or payable to the Assignor with respect to any of the foregoing; (c) all claims, causes of action and enforcement rights, whether currently pending, filed, or otherwise, with respect to the Assigned IP, including all rights to damages, injunctive relief and other remedies for past, current and future infringement of the Assigned IP; and (d) all other rights, privileges and protections of any kind whatsoever of Assignor accruing under any of the foregoing.

2. Further Assurances. Assignor covenants and agrees that, at any time and from time to time upon the request of Assignee, Assignor shall provide any further necessary documentation and do all further acts reasonably requested by Assignee to confirm and perfect title in and to the Assigned IP in Assignee, its successors and assigns. Assignor hereby

authorizes the Commissioner for Patents and the Commissioner for Trademarks of the United States Patent and Trademark Office, the Commissioner for Copyrights of the United States Copyright Office and any other government authority to record and register this Assignment upon request by Assignee.

3. Intent-To-Use Applications. Although legal title to the Intent-To-Use Applications is not being assigned pursuant to this Assignment, Assignor does hereby irrevocably contribute, transfer, convey, assign and deliver to Assignee and its successors and assigns, and Assignee does hereby unconditionally accept and assume the benefits and burdens of ownership with respect to the Intent-To-Use Applications, and the Assignor and Assignee agree to treat, for all tax purposes, that all rights and obligations in respect of the Intent-To-Use Applications have been transferred by Assignor to Assignee on the Effective Date in accordance with this Assignment and any payments, income or benefits received or derived by the Assignor after the Effective Date in respect of the Intent-To-Use Applications will be treated as received or derived as an agent or a nominee for the Assignee, and any costs, expenses, liabilities, taxes or other obligations incurred by Assignor after the Effective Date in respect of the Intent-To-Use Applications shall be for the account of the Assignee, and the Assignee agrees to pay any such costs, expenses, liabilities, taxes or other obligations directly or otherwise reimburse the Assignor for the payment thereof.

4. Entire Agreement. This Assignment (including the Attachments hereto), the IP Contribution Agreement and that certain Restructuring Plan between the Parties and certain other entities (as may be amended, restated or modified from time to time, the "Restructuring Plan") reflect the entire understanding of the Parties relating to the contribution, assignment, transfer conveyance and delivery of the Assigned IP from Assignor to Assignee, and supersede all prior written agreements, arrangements, communications and understandings and all prior and contemporaneous oral agreements, arrangements, communications and understandings between the Parties with respect to the subject matter hereof and thereof. This Assignment, the IP Contribution Agreement and the Restructuring Plan shall not be deemed to contain or imply any restriction, covenant, representation, warranty, agreement or undertaking of any Party with respect to the transactions contemplated hereby or thereby, other than those expressly set forth herein, therein or in any document required to be delivered hereunder or thereunder, and none shall be deemed to exist or be inferred with respect to the subject matter hereof or thereof. Notwithstanding any oral agreement or course of conduct of the Parties or their representatives to the contrary, no Party shall be under legal obligation to enter into or complete the transaction contemplated hereby unless and until this Agreement shall have been executed and delivered by each Party.

5. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns.

6. Governing Law. This Assignment shall be governed by and construed under the laws of the State of Delaware without regard to conflicts-of-laws principles that would require the application of any other law.

7. Dispute Resolution; Jurisdiction.

(a) Any disputes arising between the Parties pursuant to or in connection with this Assignment, including a dispute as to the validity or existence of this Assignment, will be resolved according to the dispute resolution procedures set out in the Restructuring Plan.

(b) EACH OF THE PARTIES HEREBY IRREVOCABLY WAIVES, TO THE FULLEST EXTENT PERMITTED BY LAW, ALL RIGHT TO A TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM ARISING OUT OF OR RELATING TO THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY.

8. Severability. In case any provision in or obligation under this Assignment shall be invalid, illegal or unenforceable in any jurisdiction, the validity, legality and enforceability of the remaining provisions or obligations, or of such provision or obligation in any jurisdiction, shall not in any way be affected or impaired thereby. Furthermore, in lieu of any such invalid, illegal or unenforceable provision or obligation, the Parties shall agree upon a provision or obligation to be added to this Assignment that is as similar in terms to such invalid, illegal or unenforceable provision or obligation as may be possible to be valid and enforceable.

9. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original copy of this Assignment and all of which, when taken together, shall be deemed to constitute one and the same agreement. The exchange of copies of this Assignment and of signature pages by facsimile or .pdf transmission (including via DocuSign or otherwise) shall constitute effective execution and delivery of this Assignment as to the Parties and may be used in lieu of the original Assignment for all purposes. Signatures of the Parties transmitted by facsimile or .pdf shall be deemed to be their original signatures for all purposes.
