**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest (“Release”) is given on this 30th day of June, 2023 by JPMORGAN CHASE BANK, N.A. (the “Grantee”), to MYRIAD GENETICS, INC., CRESCENDO BIOSCENCE, INC. and MYRIAD RBM, INC. (together with Myriad Genetics Inc. and Crescendo Bioscience the “Grantors”) as follows:

WHEREAS, the Grantors, the Lenders, the Administrative Agent and the Grantee have entered into a Credit Agreement dated as of December 23, 2016 (as may be amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, on December 23, 2016 the Grantors and the Grantee entered into Confirmatory Grants of Security Interest in United States Trademarks (“Confirmatory Grants”);

WHEREAS, pursuant to said Confirmatory Grants, the Grantors granted to the Grantee, among other collateral as set forth therein, a continuing security interest in all of the Grantors’ right, title and interest in, to and under its United States trademarks, including but not limited to the trademarks listed on the attached Schedule A, together with all proceeds of such trademarks and all causes of action arising prior to or after the date thereof for infringement of such trademarks (the “Trademarks”);

WHEREAS, said Confirmatory Grants were recorded in the United States Patent & Trademark Office on December 27, 2016, at Reel/Frames: 5952/0163, 5954/0991 and 5952/0193;


WHEREAS, the Grantors have satisfied the terms of the Pledge and Confirmatory Grants (including all conditions for release), and the Grantee wishes to release its security interest in the Trademarks, including those listed on Schedule A and retransfer and reassign to the Grantors without recourse all of the Grantee’s right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby (i) unconditionally terminates the Confirmatory Grants and releases any security interest, right or other interest it may have in the Trademarks, including those listed on Schedule A, and hereby reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantors and (ii) agrees to execute, acknowledge, procure and deliver to Grantors any and all further documents or instruments and do any and all further acts which the Grantors (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Grantors’s (or their assignees’) right, title and interest in and to the Trademarks.
