TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 18, 2023 (“Release”), is made by Morgan Stanley & Co. Incorporated, as Collateral Agent (“Collateral Agent”), in favor of Euro-Pro Operating LLC, a Delaware limited liability company, EP Midco LLC, a Delaware limited liability company, New Euro-Pro Holdings LLC, a Delaware limited liability company, and Euro-Pro Management Company, a Delaware Corporation (collectively, the “Grantors”, and individually, a “Grantor”).

WHEREAS, pursuant to that certain Second Lien Loan and Security Agreement dated as of August 10, 2007 (as amended, amended and restated, supplemented or otherwise modified, the “Loan Agreement”) by and among the Grantors, Collateral Agent, and others party thereto and the Trademark Security Agreement dated as of August 10, 2007 (“Trademark Security Agreement”) by and among the Grantors and Collateral Agent, Grantors granted to the Collateral Agent, for the benefit of itself and Lenders (collectively, the “Secured Parties”), a continuing second perfected security interest in all of Grantors’ right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on August 24, 2007 at Reel 3608 Frame 0328.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Secured Parties, and Grantors agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Secured Parties, hereby:

(a) terminates the Trademark Security Agreement;

(b) terminates, cancels, forever discharges, and releases the continuing second perfected security interest in all of Grantors’ right, title and interest in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and


(d) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

SECTION 3. Further Assurances. Collateral Agent, at Grantors’ expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Collateral Agent will, at Grantors’ expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
