## **RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS**

This Release of Security Interest in Patents, Trademarks and Copyrights (this "Release") is made, as of July 5, 2023, by Fifth Third Bank, National Association ("Lender"), in favor of Bonita Marie International, Inc., a New Jersey corporation ("BMI"), BMI Merchandise, Inc., a New Jersey corporation ("BMIM"), and together with BMI, collectively, "Borrowers", and BMI Group Holdings, Inc., a Delaware corporation ("Guarantor"), and together with Borrowers, collectively, "Grantors" and each a "Grantor").

### **WITNESSETH:**

WHEREAS, in accordance with the terms of that certain Credit and Security Agreement dated as of July 9, 2021 among Borrowers and Lender (as amended from time to time, the "Credit Agreement"), and that certain Guarantor Security Agreement dated as of July 9, 2021 between Guarantor and Lender (as amended from time to time, the "GSA"), Grantors executed and delivered the following: (i) that certain Patent Security Agreement dated as of July 9, 2021 among Grantors and Lender (the "Patent Security Agreement"), (ii) that certain Trademark Security Agreement dated as of July 9, 2021 among Grantors and Lender ("Trademark Security Agreement"), and (iii) that certain Copyright Security Agreement dated as of July 9, 2021 among Grantors and Lender (the "Copyright Security Agreement", and together with the Trademark Security Agreement and the Patent Security Agreement, collectively, the "IP Security Agreements" and each an "IP Security Agreement"), and pursuant to which Grantors granted a security interest to Lender in, and a lien upon: (a) all patents, patent applications and patent licenses of Grantors referred to on Schedule A annexed hereto and made a part hereof, (b) all trademarks, trademark applications and trademark licenses of Grantors referred to on Schedule B annexed hereto and made a part hereof, and (c) all copyrights, copyright applications and copyright licenses of Grantors referred to on Schedule C annexed hereto and made a part hereof (and as more particularly described in the applicable IP Agreements, collectively, the "IP Collateral"), to secure the "Obligations" (as defined in the Credit Agreement and GSA) under the Loan Documents (as defined in the Credit Agreement); and

WHEREAS, (i) the Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 21, 2021 at Reel/Frame 056936/0891, (ii) the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 21, 2021 at Reel/Frame 7361/0178, and (iii) the Copyright Security Agreement was submitted for recording with the United States Copyright Office on July 23, 2021; and

WHEREAS, Grantors have requested that Lender terminate the IP Agreements and release and reassign all liens and interests granted in favor of Lender, pursuant to the IP Agreements, in and to the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) releases and terminates its security interests in all patents, patent applications and patent licenses of Grantors as set forth on Schedule A hereto (the "Released Patents"), and reassigns to such Grantors all right, title and interest of Lender in and to the Released Patents, (ii) releases and terminates its security interests in all trademarks, trademark applications and trademark licenses of Grantors as set forth on Schedule B hereto (the "Released Trademarks"), and reassigns to such Grantors all right, title and interest of Lender in and to the Released Trademarks, and (iii) releases and terminates its security interests in all copyrights, copyright applications and copyright licenses of Grantors as set forth on Schedule C hereto (the "Released Copyrights"), and reassigns to such Grantors all right, title and interest of Lender in and to the Released Copyrights.
