## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Termination”) is dated as of July 13, 2023, and made by ASSOCIATED BANK, NATIONAL ASSOCIATION (“Lender”) to ATTICA HYDRAULIC EXCHANGE, INC., a Delaware corporation (the “Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 17, 2022, by and between by Grantor and Lender (the “Security Agreement”), a security interest was granted by Grantor to Lender in certain collateral, including the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including the Trademarks listed in Schedule A attached hereto; and

WHEREAS, Lender now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral, including the Trademarks listed in Schedule A attached hereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Lender hereby states as follows:

1. Definitions. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.
2. Release of Security Interest. Lender hereby terminates the Security Agreement and terminates, releases and discharges its security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement, in the Trademark Collateral, including the Trademarks listed on Schedule A hereto, and, all associated goodwill, and, without representation, recourse or warranty whatsoever, reassigns, transfers and conveys to Grantor all right, title and interest of Lender in the Trademark Collateral, including all associated goodwill, and any right, title or interest of Lender in such Trademark Collateral shall hereby terminate, cease and become void.
