This NOTICE OF RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL, dated as of June 20, 2023 (this "Notice"), is made by VANTAGEPOINT VENTURE PARTNERS IV(Q) L.P., VANTAGEPOINT VENTURE PARTNERS IV L.P., VANTAGEPOINT VENTURE PARTNERS IV PRINCIPALS FUND, L.P., VANTAGEPOINT PARTNERS 2006 (Q) L.P., VANTAGEPOINT CLEANTECH PARTNERS L.P. and VANTAGEPOINT CLEANTECH PARTNERS II L.P. (collectively, the "Secured Party"), in favor of BRIGHTSOURCE ENERGY, INC., a Delaware corporation ("BSE"), and the direct and indirect subsidiaries of BSE (together with BSE, the "Grantors").

1. As stated in that certain the Confirmatory Grant of Security Agreement in United States Intellectual Property, dated September 30, 2014 recorded with the U.S. Patent and Trademark Office on October 22, 2014 at Reel/Frame 034010/0100 and Reel/Frame 5385/0959 as security for the payment and performance of various obligations, the Grantors have previously granted to the Secured Party, a security interest in the following:

- (a) the patents and patent applications set forth in Exhibit A hereto and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the "Patents");
 - (b) all rights of any kind whatsoever of such Grantor accruing under any of the Patents provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
 - (c) the trademarks set forth in Exhibit B hereto, whether registered or not, (the "Marks"), and all goodwill associated therewith;
 - (d) all rights of any kind whatsoever of such Grantor accruing under any of the Marks provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world; and
 - (e) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to any past, present and future infringement, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
- (all of the rights or items described or referenced in the preceding paragraphs (a), (b),(c),(d), and/or (e) collectively, the "US Intellectual Property Collateral")

2. The Grantors have, in connection with the closing of certain transactions comprised in part of the transfer of certain intellectual property rights of the Grantors, requested that the Secured Party release its security interest in the US Intellectual Property Collateral.

3. The Secured Party, on behalf of itself, its successors, legal representatives and assigns and without representation or warranty of any kind or nature, releases its security interest in and to the US Intellectual Property Collateral.

4. The Secured Party authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record t




