**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of July 21, 2023, by **GOLDMAN SACHS SPECIALTY LENDING GROUP, L.P.**, in its capacity as collateral agent under the security agreements referred to below (“**Collateral Agent**”), in favor of **URBAN PLATES, LLC**, a Delaware limited liability company (“**Grantor**”).

**WHEREAS**, reference is hereby made to (a) that certain Pledge and Security Agreement (as supplemented or otherwise modified from time to time), dated as of September 12, 2018, executed by each Grantor in favor of Collateral Agent, and (b) that certain Trademark Security Agreement (as supplemented or otherwise modified from time to time), dated as of September 12, 2018, executed by Grantor in favor of Collateral Agent, and recorded in the records of the United States Patent and Trademark Office on September 12, 2018, at Reel/Frame 6435/0821; and


**WHEREAS**, pursuant to the above-referenced security agreements, Grantor granted to Collateral Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under all United States, state, territorial, provincial or foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, internet domain names, trade styles, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, all registrations and applications for any of the foregoing including: (a) the registrations and applications described on Schedule 1; (b) all extensions or renewals of any of the foregoing; (c) all of the goodwill of the business connected with the use of and symbolized by the foregoing; (d) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill; and (e) all Proceeds of the foregoing, including licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “**Trademark Collateral**”).

**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and adequacy of which are hereby acknowledged, Collateral Agent hereby (i) expressly irrevocably and unconditionally terminates, cancels, fully discharges and releases all security interests and continuing liens granted by Grantor in favor of Collateral Agent in any and all right, title and interest of Grantor in, to and under any and all of the Trademark Collateral, whether presently existing or hereafter created or acquired; (ii) expressly irrevocably and unconditionally assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral; (iii) authorizes Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Collateral Agent’s security interests in and liens on the Trademark Collateral; (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release and (v) affirms that the Pledge and Security Agreement and Trademark Security Agreement are hereby terminated and released and of no further force and effect.

Collateral Agent represents and warrants that it has the full power and authority to execute this Release.
