**DECLARATION UNDER 37 C.F.R. §2.20**

I, Lauren K. Tagarao, attorney at the law firm Renner, Otto, Boisselle and Sklar LLP, who serves as trademark counsel for The Tranzonic Companies attest as follows:

**THAT** the conveyance of the trademark registrations set forth in the attached Schedule A, in addition to any common law rights related thereto (collectively, the “Trademarks”) recorded at Reel/Frame 8054/0599 (“Assignment 2” – original coversheet attached) was erroneous, not proper, and did not transfer ownership of the Trademarks because Monarch Global Brands, Inc. was not the owner of the Trademarks at the time the assignment was executed.

**THAT** at the time Assignment 2 was recorded the owner of the Trademarks was Monarch Brands Global, LLC (a Delaware limited liability company), as evidenced by the assignment properly recorded at Reel/Frame 8059/0331.

**THAT**, for the above reasons, Assignment 2 was invalid, and did not transfer ownership of the Trademarks to the proposed assignee The Tranzonic Companies.

**THUS**, the chains of title associated with the Trademarks are accurate and complete with the exception of Assignment 2, which was improperly drafted and recorded.

For the foregoing reasons, the chains of title associated with the Trademarks should be corrected to reflect the invalidity of Assignment 2 and the fact that the conveyances noted therein did not occur.

The undersigned, being hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of my knowledge are true and all statements made on information are believed to be true.

## CONFIRMATORY TRADEMARK ASSIGNMENT

3. *Counterparts.* This Assignment may be executed in one or more counterparts and delivered electronically (including by electronic .pdf submission), each of which shall be deemed an original and all of which shall constitute one and the same instrument.
