**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY  
AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), is dated as of July 14, 2023, and made by **WELLS FARGO BANK, NATIONAL ASSOCIATION** ("**Secured Party**") to **ROBINSON HOME PRODUCTS INC.**, a corporation organized under the laws of the State of New York ("**Robinson**").

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement dated as of November 15, 2018 made by Robinson in favor of Secured Party (the "Security Agreement"), a security interest was granted by Robinson to Secured Party in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on November 16, 2018 at Reel/Frame 006482/0760; and

WHEREAS, Secured Party now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Secured Party hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Secured Party's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto

2. Release of Security Interest. Secured Party hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Secured Party in the Trademarks.
