CONFIRMATORY TRADEMARK ASSIGNMENT

THIS CONFIRMATORY TRADEMARK ASSIGNMENT (the "Assignment"), entered into as of the dates set forth in the signature lines below to be effective as of May 31, 2023, is between **CARLISLE WIDE PLANK FLOORS, INC.**, a Delaware corporation (the "Assignor"), and **CWPF, INC.**, a Texas corporation, having a business address of 11614 Bee Cave Road, Ste. 220, Austin TX 78738 (the "Assignee").

WHEREAS, the Assignor and the Assignee are parties to that certain Asset Purchase Agreement dated May 31, 2023 (the "Purchase Agreement");

WHEREAS, pursuant to the Purchase Agreement, the Assignor and Assignee executed an Assignment of Intellectual Property Agreement dated May 31, 2023 (the "Assignment Agreement") whereby Assignor and Assignee confirmed Assignor's assignment of certain Intellectual Property Assets, including the trademarks and trademark registrations listed in Schedule A (collectively, the "Trademarks"), to Assignee by way of the Purchase Agreement; and

WHEREAS, the parties wish to enter into this Assignment the purposes of recording this Assignment with the U.S. Patent and Trademark Office, and the corresponding entities or agencies in any applicable jurisdictions, to reflect the assignment of the Trademarks to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties do hereby agree as follows:

1. Assignment. Assignor hereby confirms that, subject to the terms and conditions of the Purchase Agreement and Assignment Agreement, Assignor sold, conveyed, transferred, assigned, and delivered to Assignee all Assignor's right, title and interest in and to the Trademarks, together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks. Assignor confirms that, with respect to the United States intent-to-use trademark applications set forth on Schedule A hereto, the transfer of such applications accompanies, pursuant to the Purchase Agreement, the transfer of Assignor's business, or that portion of the business to which the trademarks pertain, and that business is ongoing and existing.

2. Recordation. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee.

3. Terms of the Agreements. The parties hereto acknowledge and agree that this Assignment is entered into pursuant to the Purchase Agreement and Assignment Agreement, to which reference is made for a further statement of the rights and obligations of the Assignee and the Assignor with respect to the Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Purchase Agreement and Assignment Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the either Purchase Agreement or Assignment Agreement and the terms hereof, the terms of the Purchase Agreement or Assignment Agreement shall govern, as applicable.

4. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic

transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

5. Governing Law. This Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
