**TRADEMARK RELEASE AGREEMENT**

THIS TRADEMARK RELEASE AGREEMENT (the “Release”) is made as of July 11, 2023, by BMO HARRIS BANK N.A., as Agent (“Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, BENEFIT RESOURCE LLC, a Delaware limited liability company (the “Grantor”), and Agent are parties to that certain Trademark Collateral Agreement dated August 15, 2019 (the “Security Agreement”), pursuant to which Grantor granted a security interest to Agent in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the trademarks set forth on Schedule A hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office (“USPTO”) on August 15, 2019, at Reel 6720 Frame 0698;

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its continuing security interest in all of Grantor’s right, title and interest in each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and all proceeds thereof, including, without limitation, any and all claims and causes of action which may exist by reason of past, present or future infringement thereof or by reason of injury to the goodwill associated therewith and any and all damages arising therefrom, including from past, present and future violations thereof (collectively, the “Trademark Collateral”);

2. Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the Trademark Collateral; and

3. Agent hereby authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at Grantor’s expense.
