## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is entered into and effective May 25, 2023 (the “Effective Date”), by HarperCollins Publishers L.L.C., a Delaware limited Liability company (“Assignor”) and Houghton Mifflin Harcourt Publishing Company, a Massachusetts corporation with its principal place of business in Boston, Massachusetts (“Assignee”). (Assignor and Assignee are collectively referred to as the “Parties”).

WHEREAS, the Parties entered into that certain Asset Purchase Agreement of March 26, 2021 (the “APA”) whereby Assignor acquired Assignee’s retail trade publishing business and related assets;

WHEREAS, the APA assigned certain trademarks to Assignor, and the Parties inadvertently included the trademark STREAM TO START (the “Mark”) among the schedule of trademarks in the APA;

WHEREAS, Assignee originally registered the Mark for use in connection with production and distribution of educational videos for the internet, U.S. Federal Trademark Registration No. 5,228,157, issued June 20, 2017 in International Class No. 41, and Assignee has since continuously used the Mark in connection with its educational publishing business and not in connection with retail trade publishing;

WHEREAS, Assignee is desirous of acquiring and Assignor is desirous of reverting to Assignee all right, title and interest in the Mark and associated goodwill – including rights to the U.S. Trademark Registration No. 5,228,157 for the services identified therein and any common law rights associated with the Mark, together with the goodwill of the business symbolized by and associated with the Mark;

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee the entire right, title and interest in and to the STREAM TO START Mark, U.S. Trademark Registration No. 5,228, 157 for the services identified therein, any common law rights and goodwill associated with the STREAM TO START Mark, and related registration, including without limitation,

the right to sue and collect damages and profits and obtain any other recovery for past infringement, if any, and the right to stand in the place of Assignor in all matter related thereto.
