## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of July 25, 2023, (this “Agreement”), among THIRDLOVE, INC., a Delaware corporation (the “Grantor”) and SECOND AVENUE CAPITAL PARTNERS LLC, as administrative agent and collateral agent (in such capacities, the “Agent”) for the ratable benefit of the Credit Parties (as defined in the Credit Agreement described below).

Reference is made to that certain (i) U.S. Security Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “U.S. Security Agreement”), among the Grantor and the Agent and (ii) Canadian Security Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Canadian Security Agreement”; together with the U.S. Security Agreement, collectively, the “Security Agreements”) among the Grantor and the Agent. The Lenders (as defined below) have extended credit to the Grantor pursuant to that certain Credit Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among the Grantor, the Guarantors (as defined in the Credit Agreement) party thereto from time to time, the lenders party thereto from time to time (the “Lenders”) and the Agent.

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreements or the Credit Agreement, as applicable.

SECTION 2. Grant of Security Interest. As collateral security for the payment and performance in full of all the Secured Obligations, the Grantor, pursuant to the Security Agreements, did and hereby does pledge and grant to the Agent, for its benefit and for the benefit of the other Credit Parties, a Lien on and security interest in and to all of its right, title and interest in, to or under all of the following assets, whether now existing or hereafter arising or acquired from time to time:

- (a) all Trademarks, including the Trademark registrations and registration applications in the United States Patent and Trademark Office or the Canadian Intellectual Property Office listed on Schedule I hereto, and all Goodwill of the business symbolized by the foregoing, but excluding any intent-to-use trademark applications, for which statement of use has not been filed (but only until such statement is filed and accepted by the United States Patent and Trademark Office so that the interests of the Grantor in such mark is no longer on an intent-to-use basis);
- (b) all Patents, including the Patent registrations and pending applications in the United States Patent and Trademark Office or the Canadian Intellectual Property Office listed on Schedule II hereto;
- (c) all Copyrights, including the Copyright registrations and pending applications for registration in the United States Copyright Office or the Canadian Intellectual Property Office listed on Schedule III hereto; and
- (d) all proceeds of the foregoing;

in each case to the extent the foregoing items constitute Collateral.

SECTION 3. Security Agreements. The security interests granted to the Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Agent pursuant to the Security Agreements. The Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the Intellectual Property Collateral are more fully set forth in the Security Agreements. In the event of any conflict between the terms of this Agreement and the Security Agreements, the terms of the Security Agreements shall govern.

SECTION 4. Recordation. This Agreement has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein and in the Security Agreements with the United States Patent and Trademark Office, the United States Copyright Office and the Canadian Intellectual Property Office, as applicable. The Grantor authorizes and requests that this Agreement be recorded with the United States Patent and Trademark Office, the United States Copyright Office and the Canadian Intellectual Property Office, as applicable.


SECTION 5. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO PRINCIPLES OF CONFLICTS OF LAWS THEREOF, BUT INCLUDING SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW.

SECTION 6. Successors and Assigns; Counterparts. This Agreement shall be binding upon the successors and assigns of the Grantor and shall inure to the benefit of the Agent and each other Credit Party and their respective successors and assigns. This Agreement may be executed in any number of counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by telecopy, pdf or other electronic transmission shall be as effective as delivery of a manually executed counterpart of this Agreement.


