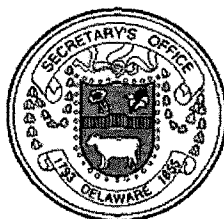

THIRD: The name of the surviving corporation is Cameron International Corporation.

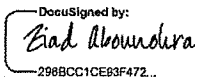
FOURTH: The merger is to become effective on Jan. 3 2022 - 11:00AM EST.
