**CONFIRMATORY ASSIGNMENT** dated 26 July 2023

**PARTIES**

- 1 **GOOGLE LLC** incorporated and registered in Delaware whose registered office is at 1600 Amphitheatre Parkway, Mountain View, California, United States, 94043 (the "**Assignor**"); and
- 2 **LOWRISC C.I.C.** incorporated and registered in England and Wales with company number 09272283 whose registered office is at 7 Hills Road, Cambridge, England, CB2 1GE (the "**Assignee**").

**BACKGROUND**

- 1 By virtue of the Main Agreement (as defined below), the Assignor assigned all rights in and to the Trade Marks (as defined below) to the Assignee on the Effective Date.
- 2 The Assignor and Assignee wish to enter into this Confirmatory Assignment to confirm the assignment of the Trade Marks to the Assignee by the Assignor.

**AGREED TERMS**

**1 INTERPRETATION**

The following definitions apply in this Assignment.

1.1 Definitions:

1.1.1 "**Effective Date**" means 31 March 2023.

1.1.2 "**Main Agreement**" means the Trade Mark Assignment Agreement dated 31 March 2023 between the Assignor and the Assignee.

1.1.3 "**Trade Marks**" means the registered trade marks, trade mark applications and unregistered trade marks short particulars of which are set out in Schedule 1 to this Confirmatory Assignment.

**2 ASSIGNMENT**

2.1 Pursuant to the terms and consideration specified in the Main Agreement and the sum of £1 paid by the Assignee to the Assignor (receipt of which the Assignor expressly acknowledge), the Assignor hereby confirms the assignment on the Effective Date to the Assignee absolutely with full title guarantee all rights, title and interest in and to the Trade Marks, including:

2.1.1 the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Trade Marks;

2.1.2 all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and


2.1.3 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of the Trade Marks whether occurring before, on or after the Effective Date.

The Assignor shall and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute and deliver such documents and perform such acts as may be required for the purpose of giving full effect to the Main Agreement and this Confirmatory Assignment.
