NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:



3. For administrative convenience, EMC may file with the USPTO to assign the Marks directly to EOI.



7. Copies of the Agreement of Merger will be furnished by the surviving corporation on request, and without cost, to any stockholder of any constituent corporation or member of the aforesaid constituent limited liability companies.
8. The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
