TERMINATION AND RELEASE TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of July 28, 2023, and made by **PNC BANK, NATIONAL ASSOCIATION**, as Agent (the "Grantee"), to **AABACO SMALL BUSINESS, LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Amended and Restated Revolving Credit and Security Agreement dated as of October 3, 2017, made by Grantor, Grantee and others party thereto (the "Credit Agreement") and the Trademark Security Agreement dated as of June 10, 2022, made by Grantors in favor of Grantee (the "Security Agreement"; all capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement or Security Agreement, as applicable), Grantor granted to Grantee, for the benefit of the Lenders, a continuing first priority security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 13, 2022, at Reel/Frame 007750/0112;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Release of Security Interest. Grantee, without representation, warranty or recourse, hereby terminates the Security Agreement and terminates, releases and discharges any and all security interest in the Trademark Collateral, including the Trademark Collateral listed on Exhibit A hereto, and any right, title or interest of the Grantee in the Trademark Collateral shall hereby cease and become void.


2. Recordation. The Grantee authorizes Grantor and its agents and designees to record this Termination with the United States Patent and Trademark Office or any other applicable governmental authority or agency at Grantor's expense.
