CONFIRMATORY SECURITY AGREEMENT

WHEREAS SENSOR NETWORKS, INC. (the **Grantor**), having its registered office at 366 Walker Drive, State College, PA 16801 is the registered owner of the United States patents, patent applications, trademarks and trademark applications listed in Schedule "A" hereto and may, in the future, become the registered owner of additional United States patents and trademarks and patent and trademark applications (collectively, the **Intellectual Property**);

WHEREAS NATIONAL BANK OF CANADA, in its capacity as administrative agent or hypothecary representative, as the case may be (in each such capacity, the **Creditor**), having a place of business at 500 Place d'Armes, 26th Floor, Montréal, Québec H2Y 2W3, Canada, entered into a pledge and security agreement on January 30, 2020 with Eddyfi Corp., Eddyfi Holding USA Inc. and the other grantors from time to time party thereto, as grantors, to which the Grantor became a party as grantor on June 24, 2023, 2023 (the **Security Document**), pursuant to which the Grantor assigned, pledged and granted to the Creditor a security interest in and to, among other things, the Intellectual Property;

WHEREAS the Grantor and the Creditor have perfected (rendered opposable) the Security Document in the Intellectual Property in accordance with the laws of the Province of Québec, Canada and in accordance with the Uniform Commercial Code;

WHEREAS the Grantor and the Creditor are desirous of recording the Security Document and the additional security created hereunder in the Intellectual Property with the United States Patent and Trademark Office;

NOW THEREFORE, the Grantor and the Creditor hereby confirm that the Grantor and the Creditor entered into the Security Document, pursuant to which the Grantor granted to the Creditor a security interest in and to, among other things, the Intellectual Property.

AND, for good and valuable consideration, receipt of which is hereby acknowledged, the Grantor does hereby further grant to the Creditor a security interest in the Intellectual Property.

AND each party hereto does hereby further acknowledge and affirm that the rights and remedies of the Creditor with respect to the security interest in the Intellectual Property made and granted hereby are more fully set forth in the Security Document, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.




