It is hereby certified pursuant to Section 18-202 of the Delaware Limited Liability Company Act that:

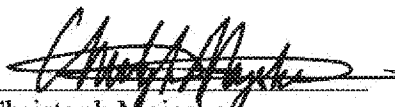
1. The name of the limited liability company (hereinafter called the "Company") is Marble Arch LLC.
