RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS, effective as of July 21, 2023 given by CIBC Bank USA, with principal offices at 120 S. LaSalle Street, Chicago, Illinois 60603, in its capacity as administrative agent for the benefit of the financial institutions (the “Lenders”) that are parties to the Credit Agreement referenced in the Security Agreement referenced below (in such capacity, the “Administrative Agent”), to Reelcraft Industries, Inc., an Indiana corporation (“Grantor”), as follows:

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement dated as of March 6, 2020, as amended by that certain First Amendment to Patent and Trademark Security Agreement, dated as of October 4, 2022 (“Security Agreement”), made by Grantor in favor of Administrative Agent, a security interest was granted by Grantor to Administrative Agent in the Patent Collateral and the Trademark Collateral as those terms are defined in the Security Agreement, including without limitation those items listed on Schedule A hereto;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on March 12, 2020, at Reel 6889, Frame 0523, and in the Patent Division of the United States Patent & Trademark Office on March 12, 2020, at Reel 052093, Frame 0776; and

WHEREAS, Grantor desires Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the Patent Collateral and the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantor the continuing security interest in, and any other interest Lenders may have in, Grantor’s right, title, and interest in, to, and under the Patent Collateral and the Trademark Collateral.

The Administrative Agent authorizes and requests that the Commissioner for Patents, Commissioner for Trademarks, and any other applicable government officer record this Release.

This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.
