**ARTICLES OF AMENDMENT OF THE
AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF
INDEPENDENT STATIONERS, INC.**

The undersigned officer of Independent Stationers, Inc., an Indiana corporation (the "Corporation"), pursuant to the provisions of the Indiana Business Corporation Law, as amended, (the "Act"), desiring to give notice of corporate action effectuating amendment of certain provisions of its Amended and Restated Articles of Incorporation, hereby certifies the following facts:

**ARTICLE I
AMENDMENT**

The date of incorporation of the Corporation is July 21, 1977.

The exact text of Article I of the Amended and Restated Articles of Incorporation of the Corporation is now as follows (the "Amendment"):

**"ARTICLE I
NAME**

The name of the Corporation is "Independent Suppliers Group, Inc."

The date of the Amendment's adoption is September 17, 2018.

**ARTICLE II
MANNER OF ADOPTION AND VOTE**

The Board of Directors of the Corporation, acting at a duly called and constituted meeting held on August 28, 2018, adopted resolutions (a) approving the Amendment, (b) directing that it be submitted to the Shareholders entitled to vote in respect of the Amendment and (c) recommending the adoption of the Amendment.

Shareholders holding a majority of the shares entitled to vote in respect of the Amendment adopted and approved the Amendment at a duly called and constituted special meeting of Shareholders held on September 17, 2018.

The manner of adoption of the Amendment and the vote by which it was adopted constitute full legal compliance with the provisions of the Act, the Amended and Restated Articles of Incorporation and the By-Laws of the Corporation.

The Amendment shall become effective when filed with the Indiana Secretary of State.
